## **ReWed Terms of Service**

**Effective Date: Feb 6, 2025**

### **Welcome to ReWed!**

These Terms of Service ("Terms") govern your use of ReWed's online resale platform. By accessing or using our platform as a User (User is defined as a "Seller" or a "Buyer"), you agree to be bound by these Terms.

#### **1. User Accounts**

To sell or buy on ReWed, you may need to create an account. You're responsible for keeping your account information confidential and for all activity under your account.

#### **2. Your Content**

**a. Responsibility:** You're solely responsible for all content you post on ReWed ("Your Content"). This includes ensuring you have all necessary rights to use the content and that it doesn't violate any third-party rights.

**b. Permission for ReWed:** By posting content, you grant ReWed and authorized third parties a non-exclusive, worldwide license to use it. This allows us to operate and promote ReWed, your shop, and listings in various ways. For example, we may display your listings to Buyers and promote them through advertising.

**c. Rights Granted to ReWed:** Specifically, you grant ReWed a license to use, display, edit, modify, reproduce, distribute, store, and create derivative works of Your Content. This allows us

to provide services and promote ReWed in any format or channel, including across ReWed platforms, partner websites, or advertising mediums. You agree not to claim any moral rights or rights of publicity against us for this use.

### **3. Orders and Payments**

When you buy an item on ReWed, you agree to pay the listed price and any applicable shipping and handling fees. We may use third-party payment processors to handle transactions.

### **4. Seller Responsibilities**

- Sellers can upload up to 3 photos of the item they wish to sell
- Sellers set their prices for the items they list for sale
- Sellers are responsible for updating their inventory
  - If an item is no longer available for sale, the Seller has to remove it from the inventory list. If the Seller fails to do so may be responsible for monetary reimbursement to the Buyer
- Only wedding-related items are to be listed for sale on myrewed.com
  - The Admin of myrewed.com has the right to remove any items, which do not meet this criteria

### **4. Shipping and Delivery**

ReWed is not responsible for delays or damages during shipping.

It's your responsibility (both Seller and Buyer) to ensure the shipping address is correct.

### **5. Returns and Refunds**

ReWed does not handle returns and refunds directly. If you have an issue with an order, reach out to the Seller directly.

### **6. Disputes**

We encourage resolving disputes with other Users directly.

Buyers and Sellers who are unable to resolve a dispute related to a transaction on our websites or mobile apps may participate in our case system with a registered account. In our sole discretion, ReWed will attempt to help you resolve disputes in good faith, but we will not make judgments or determinations regarding legal issues or claims. ReWed has no obligation to

resolve, or to assist in resolving, any disputes relating to items listed, sold, and/or purchased on the myrewed.com platform.

## **7. Release**

You release ReWed from any claims or damages arising from disputes with other Users or third parties.

## **8. Intellectual Property**

All content on ReWed, including trademarks, copyrights, and other intellectual property, is owned by ReWed or its licensors. You may not use our intellectual property without our prior written consent.

## **9. Prohibited Activities**

You may not use ReWed to:

- Sell counterfeit or unauthorized products.
- Violate any laws or regulations.
- Engage in fraudulent or deceptive activities.
- Harm or harass other Users.

Our Site is not directed to children under the age of 18, and our Terms of Service prohibit minors from using our Site or Service.

## **10. Termination**

We may terminate your account or access to ReWed for any reason at any time. Conversely, you can terminate your account, though this may not affect the availability of some previously posted content.

## **11. Termination by ReWed**

Terminating your account may result in the loss of information associated with your account, including Your Content. ReWed also reserves the right to change, suspend, or discontinue any part of the Services at any time.
